(AEDAS) from the **BCN GLOBAL 100** and **BCN MID-50** indices.

The **BCN GLOBAL 100**, **BCN SERVICIOS INMOBILIARIOS** and **BCN MID-50** indices adjustment will take place after close of trading on **March 6th 2026**.

These changes will be applied as from **March 9th 2026**.
